## Rules and Regulations

1. MHSAA rules and regulations govern this tournament.
2. This event is open to all current high schools that have a Varsity bowling team in high school competition.
3. Entry fee is \$80 per team and must accompany the entry form. No refunds will be issued. Checks returned will be assessed a \$25 fee.
4. Check in opens at 11:30 am. Bowling begins at 12:30. Coaches meeting at 12:15.
5. There will be 15 minutes of practice. Each team will practice on one lane then switch after 7.5 minutes of practice.
6. All Coaches will be required to initial score sheets. Errors in reporting must be reported to the Tournament Manager. Any scoring changes to submitted scores can only be done by the Tournament Manager. Any score changes on the floor may be done with the approval of the opposing Coach.
7. Awards will be given to the top two teams for boys and girls.
8. All equipment used in this tournament must meet USBC specifications.
9. USBC oil pattern is being used (to be determined).
10. Altering the surface of the ball is not permitted once it has been used in competition and shall result in disqualification. If a different ball is needed it may be altered only before it is used in competition.
11. Bowling Attire: All team members and coaches should be dressed alike in shirts and the same color. School shirts must reflect the name of the school and/or the school logo or mascot. Shorts and skirts will not be allowed. No hats allowed. Cell phones and other electronic devices must be turned off and not used during this tournament.
12. Only registered team members and coaches will be allowed in the bowling level area.
13. Coaches are responsible for checking in their teams prior to competition.
14. Bowling shall begin at the designated time unless the Tournament Manager authorizes a delay. Any player or team arriving late shall be allowed to begin play but will be assessed a zero frame for all frames missed.
15. No tobacco products, consumption of alcoholic beverages or unsportsmanlike conduct will be permitted while participating in this event. Outside food or drinks are not permitted to be brought into the center. Bowlers will not be permitted the use of amusement games or pool tables during the team's competition.
16. Any disputes during the tournament or exceptions to the above rules and regulations will be resolved at the discretion of the Tournament Manager.
17. The decision of the Tournament Manager is final.

## Mason High School Capitol Area Baker Tournament Format

1. The tournament is limited to 12 boys' and 12 girls' teams. Each team will bowl a qualifying round of 5-two game baker sets.
2. The field will be cut to the top 8 boys and 8 girls teams based on the total pins bowled during the 10 baker games. If there is a tie to determine the last place team, the team with highest baker game will advance.
3. Altering the surface of a bowling ball is not permitted once it has been used in competition. If a different ball is needed it may be altered only before it is used in competition.
4. Teams that start on the odd lane will move left after each baker game set. Teams on the even move right.
5. We will be alternating lanes each frame. This format is to be used throughout the tournament.
6. After the top 8 teams have been determined they will be divided into 2 divisions. The odd number teams will be in division 1 and the evens in division 2. Each team will bowl (1) baker game against each team in their division. 20 points will be awarded to each winning team. In the event of a tie each teams will receive 10 points.
7. Points from the qualifying round and the head to head single game bakers, including bonus points will be totaled to determine the top 2 teams in each division.
8. After the top 2 teams have been determined in each division, the teams will cross divisions and bowl 2 baker games against each other as shown below:  
The highest seeded team will start on the left lane. Division 1 first place team bowls the Division 2 second place team. Division 1 second place team bowls the Division 2 first place team. The two teams with the highest 2-game total will bowl in the final. Champion will be determined by a 2-game Baker set. If time permits the lanes used for the championship will be redressed.
9. Tie Breaker for Championship: An additional baker game will be bowled if time permits. If there is not enough time then the highest baker game bowled in the 2 games will decide the winner. If a tie breaker baker is bowled and a tie still exists after the tie breaker, the winner will be determined by the highest baker game bowled during the championship round.
10. An awards ceremony will be held immediately following the championship matches.
11. ALL bowlers must be ready to bowl when it is their turn due to the limited amount of time to complete the tournament.
